

## Jingle Bucks 2022 Rules

**Drawing date is Thursday, December 15, 2022, at 1:00 p.m. in Dayton, Ohio.**

1. By submitting a completed registration form and accompanying payment, entrants accept the rules as stated.
2. Purchasers must be 18 years of age or older at time of purchase.
3. Based on IRS regulations, ticket purchases do not qualify as charitable donations. Payments are not tax-deductible.
4. Payments may be made by check, MasterCard, Visa, and Discover.
  - a. Checks are made payable to Choices InCommunity Living, 1651 Needmore Road Dayton, OH 45414.
    - i. Registration forms and payment sent in the mail must be **postmarked by Wednesday, December 7, 2022** to ensure they will be received by Choices staff before the drawing date, December 15<sup>th</sup>.
  - b. Credit card payments may be made through the Choices secure website at <https://bit.ly/JingleBucks2022> or over the phone at (937) 937-898-2220.
    - i. Online and phone purchases must be completed by 1:00 p.m. on December 14, 2022 to ensure Choices staff has adequate time in verifying all tickets.
  - c. Only 500 tickets will be sold, if all are sold before above mentioned dates/times then Choices staff will contact the entrant.
  - d. All registrations will be recorded on a first come, first served basis. Registrations are final, no refunds. (Unless entrant tried to purchase after all 500 tickets were sold, entrant will be offered refund.)
5. Confirmation of your ticket purchase/numbers will be mailed within 5 business days after receipt of payment. If payment is dishonored, Choices will use reasonable efforts to notify the entrant by mail, email, or phone. If unsuccessful, the entry will be invalid unless payment is confirmed prior to the drawing.
6. Choices employees who specifically organize event are not eligible to participate.
7. The name of the winner will be available to the media, other ticket purchasers and displayed on the Choices' website and social media platforms.
8. Purchaser's odds of winning will be determined by the number of tickets sold. Only 500 tickets will be sold. In the event 500 tickets have not been sold at the time of the drawing, the winner will receive 50% of the proceeds from the total amount of tickets sold. The winner is responsible for all applicable taxes.
9. More than one name may be stated on the registration form, however the first name listed will be considered the entrant. The Social Security number must be that of the entrant for payment to be completed. Payment will be made solely to the entrant and it is their responsibility (not that of Choices) to allocate the prize among participants if ticket was a multiple entry.
10. The winner will be determined by random drawing on Thursday, December 15, 2022, at 1:00 p.m. in Dayton, OH. Winner need not be present to win.
11. Proceeds go to Choices in Community Living, in support of people with intellectual/developmental disabilities served by Choices In Community Living, Inc.
12. The decision of Choices In Community Living shall be final on all matters regarding Jingle Bucks 2022. Jingle Bucks 2022 is void where prohibited by law.
